## Non-Compete, Non-Disclose, Non-Circumvent Agreement

This Non-Compete, Non-Disclose, Non-Circumvent Agreement ("Agreement") is made and entered into as of [Date \_\_\_\_\_] by and between Rastafari TV Network, Inc., a Florida corporation with its principal place of business at P.O. **Purpose:** The purpose of this Agreement is to protect the confidential information, trade secrets, and business interests of Partner and to prevent Content Creator from engaging in activities that may compete with or harm the business of Employer.

**Term:** This Agreement will commence on the date of Employee's employment with Employer and will continue for a period of [ \_\_\_\_\_ ] years after the termination of Content Creators agreement.

**Non-Disclose:** During the term of this Agreement and at all times thereafter, Content Creator shall not disclose to any person or entity, or use for Partner benefit or the benefit of any other person or entity, any confidential or proprietary information of Partner, including but not limited to business plans, customer lists, pricing information, and trade secrets.

**Non-Circumvent:** During the term of this Agreement and at all times thereafter, Content Creator shall not directly or indirectly solicit, interfere with, or attempt to do business with any customer, supplier, or business partner of Partner.

**Governing Law:** This Agreement will be governed by and construed in accordance with the laws of the State of [Florida].

**Entire Agreement:** This Agreement constitutes the entire agreement between the parties and supersedes all prior agreements or understandings, whether written or oral. This Agreement may not be amended or modified except in writing signed by both parties.

## Agreement for Content Rights

This Agreement ("Agreement") is made and entered into as of [DATE \_\_\_\_\_] by and between [Rastafari TV Network, Inc.,], a [Florida, USA] corporation ("Network"), and [CONTENT OWNER], a [STATE/COUNTRY \_\_\_\_\_] corporation ("Content Owner").

### RECITALS:

- A. Network is in the business of distributing video content via a digital streaming platform.
- B. Content Owner is the owner of certain video content ("Content") that it desires to have distributed via Network's digital streaming platform.
- C. Network is willing to distribute the Content via its digital streaming platform, subject to the terms and conditions set forth in this Agreement.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

- **GRANT OF RIGHTS.** Subject to the terms and conditions of this Agreement, Content Owner hereby grants to Network the non-exclusive, worldwide right and license to distribute, display, perform, and transmit the Content via Network's digital streaming platform.
- **TERM.** The term of this Agreement shall commence on the date of execution and shall continue for a period of [NUMBER] years, unless earlier terminated in accordance with the terms of this Agreement.
- **REVENUE SHARING.** Network shall pay to Content Owner a percentage of the revenue generated from the distribution of the Content via Network's digital streaming platform, as follows: [PERCENTAGE]% of gross revenue. Payment shall be made on a monthly basis, within [NUMBER] days of the end of each month.
- **REPRESENTATIONS AND WARRANTIES.**

(a) Content Owner represents and warrants that it is the sole and exclusive owner of all rights in and to the Content, and that it has the right and authority to grant the rights granted to Network under this Agreement.

(b) Content Owner further represents and warrants that the Content does not infringe upon the intellectual property rights of any third party, and that the distribution and display of the Content by Network will not violate any laws or regulations.

- **INDEMNIFICATION.** Content Owner shall indemnify and hold Network, its affiliates, and their respective officers, directors, employees, and agents, harmless from and against any and all claims, damages, liabilities, costs, and expenses (including reasonable attorneys' fees) arising out of or in connection with any breach of the representations and warranties set forth in Section 4.



## Agreement for Content Rights (continued)

**TERMINATION.** This Agreement may be terminated by either party upon written notice if the other party breaches any material term or condition of this Agreement. Upon termination, all rights granted to Network under this Agreement shall immediately terminate, and Network shall promptly remove the Content from its digital streaming platform.

### MISCELLANEOUS.

(a) This Agreement constitutes the entire agreement between the parties with respect to the subject matter hereof, and supersedes all prior and contemporaneous agreements and understandings, whether oral or written.

(b) This Agreement may not be amended or modified except in writing signed by both parties.

(c) This Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.

(d) This Agreement shall be governed by and construed in accordance with the laws of the State of [STATE].

## Partnership Agreement with Content Creator

The Company and the Content Creator agree to enter into a partnership to create and distribute content (the "Content") through the Company's online and/or digital TV platforms and the Content Creator's social media channels.

- **Term of Partnership.** The term of this partnership shall begin on [Date \_\_\_\_\_] and shall continue until terminated by either party upon [\_\_\_\_\_] days' written notice.
- **Scope of Partnership.** The Content Creator shall create and produce the Content, and the Company shall publish and distribute the Content through its online platforms and/or digital TV stream and the Content Creator's social media channels. The Content shall be owned by the Company and the Content Creator shall have a perpetual, non-exclusive license to use the Content for personal and promotional purposes.
- **Compensation.** The Company shall pay the Content Creator a fee of 40% for any advertisement or sponsorship sold or generated for each piece of Content created and delivered to the Company. Payment shall be made within [30] days of receipt of the Content, when applicable.
- **Intellectual Property.** The Content Creator shall retain ownership of any intellectual property rights in any ideas, concepts, or materials developed by the Content Creator outside of the scope of this partnership. The Company shall retain ownership of all intellectual property rights in the Content.
- **Confidentiality.** The Content Creator shall maintain the confidentiality of all confidential information disclosed by the Company and shall not disclose such information to any third party without the prior written consent of the Company.
- **Termination.** This Agreement may be terminated by either party upon [30] days' written notice. Upon termination, the Content Creator shall return all confidential information and materials in the Content Creator's possession or control to the Company.
- **Governing Law.** This Agreement shall be governed by and construed in accordance with the laws of the State of [Florida, USA].
